

# **VISION FOR HEROES DONATION TERMS & CONDITIONS**

## **Terms & Conditions:**

1. **Eligibility:** This Offer is open only to those who sign up using the Nomination Form and who are 18 years old as of the date of entry. This Offer is only open to legal residents of the United States and is void where prohibited by law. This Offer is subject to all applicable federal, state, and local laws and regulations.
2. **Agreement to Rules:** By participating, the Nominator (“you”) agree to be fully and unconditionally bound by these Rules and our Privacy Policy, and you represent and warrant that You meet the eligibility requirements.
